# Notice of Public Meeting Committee of Adjustment

**Application for Consent to Sever has been submitted by Willy Goertz, owner of the subject lands.**

**Property Location: Municipal Address not yet assigned**

## **What is being proposed?**

The application proposes to create one (1) new lot, for a total of two (2) lots.

The subject lands have a frontage of approximately 30.48 metres (100 ft.) along 58<sup>th</sup> Street South and a frontage of approximately 28.77 metres (94.39 ft.) along Robinson Road. The subject lands have an area of approximately 883 square metres (9,504.53 sq. ft.).

The portion of the property proposed to be severed, as shown on the severance sketch provided as 'Part 2' has a frontage of approximately 13.72 metres (45.01 ft.) along 58<sup>th</sup> Street South, a depth of approximately 29.14 metres (95.6 ft.) and an area of approximately 397.2 square metres (4,275.42 sq. ft.).

The portion of the property proposed to be retained, as shown on the severance sketch provided as 'Part 1' has a frontage of approximately 16.76 metres (54.98 ft.) along 58<sup>th</sup> Street South, a frontage of approximately 28.77 metres (94.39 ft.) along Robinson Road, and an area of approximately 482.2 square metres (5,190.35 sq. ft.).

**OTHER APPLICATIONS:** The property subject to this application for Consent is currently the subject of an application for Minor Variance (Town File A04124) under the *Planning Act*.

The legal description of the subject lands is RCP 1696 PT LOT 17 RP;51R41313 PART 2.

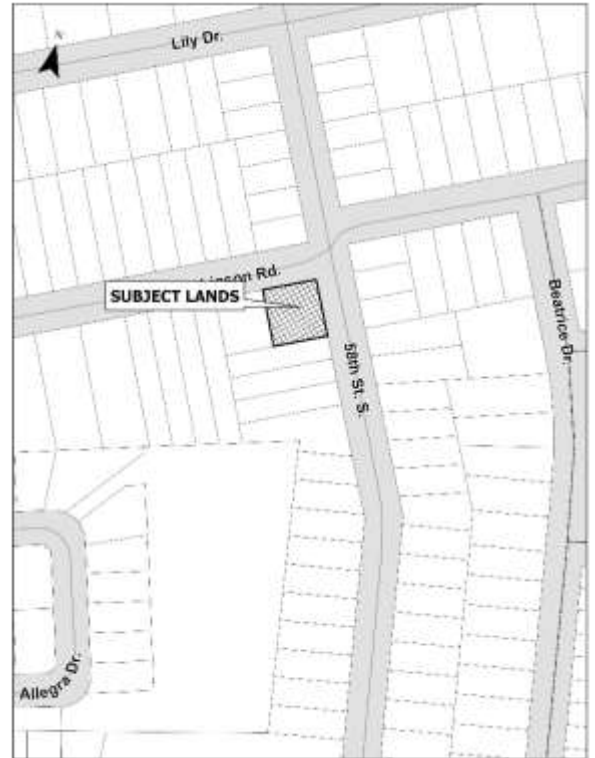
The public hearing is your chance to make your views about the proposal known. Information from the public will help the Committee in their decision-making process, so make sure to have your say!

**A note about information you may submit to the Town:**

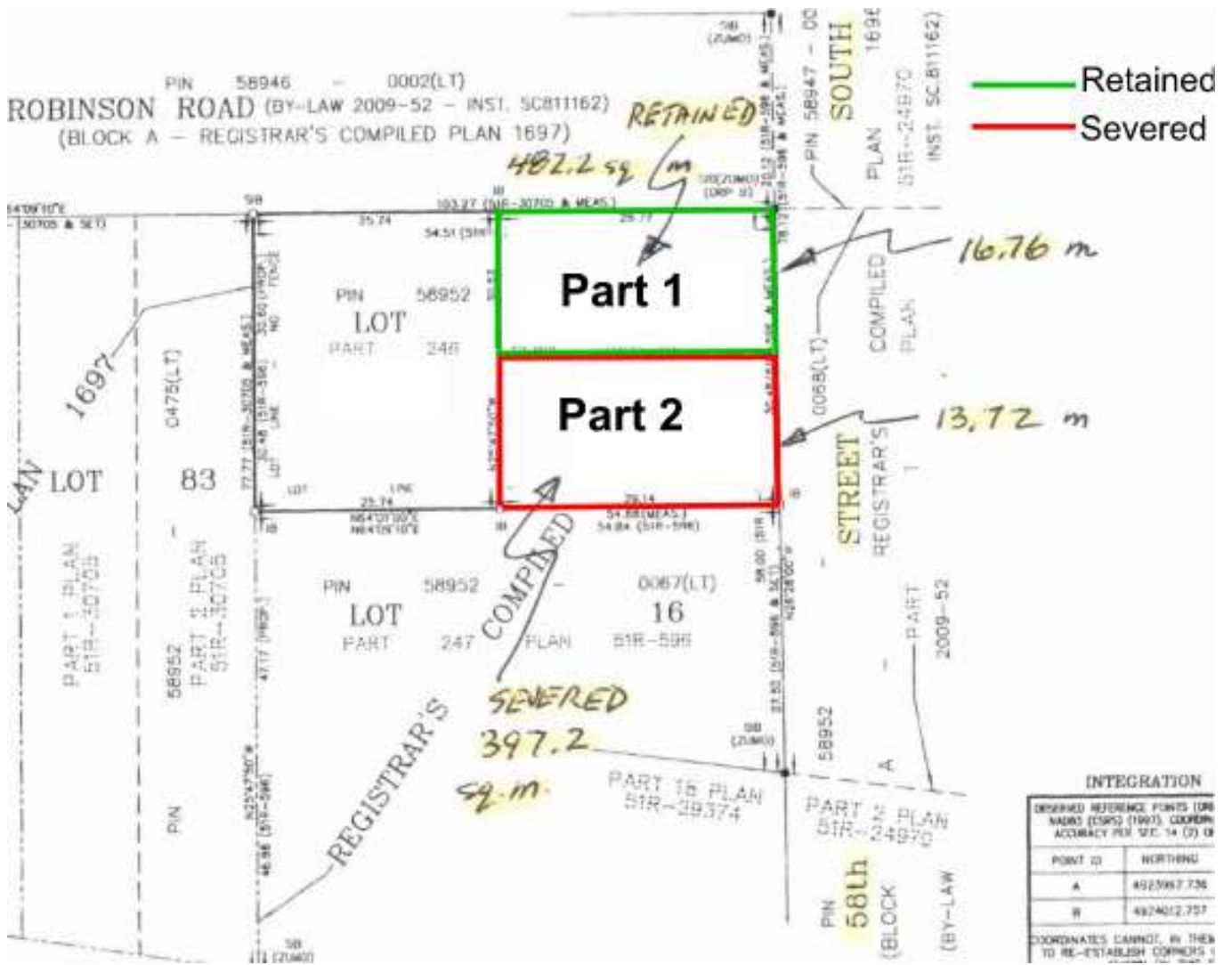

If an applicant, a specified person or public body that files an appeal of a decision of Town of Wasaga Beach Committee of Adjustment in respect of the proposed Consent does not make written submission to Town of Wasaga Beach Committee of Adjustment before it gives or refuses to give provisional consent, the Ontario Land Tribunal may dismiss the appeal.
